

# Aboriginal and Torres Strait Islander scholarship

## Application

### CPA Australia Aboriginal and Torres Strait Islander Scholarships

CPA Australia offers up to five scholarships annually for Aboriginal and Torres Strait Islanders. The scholarship will assist recipients to meet the educational requirements needed to attain CPA status. Scholarship recipients will receive complimentary enrolment for CPA Program subjects not yet undertaken, and one waived CPA Australia Associate (ASA) membership fee for three (3) years of membership.

### Eligibility

To be eligible for the scholarship, applicants must:

- be aged 18 years or over;
- be assessed or have been assessed as eligible to join CPA Australia at [Associate level](#). To be eligible to join as Associate member, you must have completed a [CPA Australia-Accredited Course\\*](#) or be assessed as meeting all of the [Foundation competency requirements](#); and
- be residing in Australia and an Australian resident for tax purposes for the duration of the scholarship.

To complete the CPA Program, applicants must hold as a minimum, an Australian bachelor's degree that is accredited by CPA Australia, or an overseas bachelor's degree that CPA Australia has assessed as being comparable to an Australian bachelor's degree. Applicants may need to complete additional accredited units to meet Associate membership requirements. Applicants can apply to join CPA Australia before their tertiary results are finalised.

### Selection process

The scholarship will be awarded by CPA Australia solely based on merit, against the selection criteria set out in the [CPA Australia 'Aboriginal and Torres Strait Islander Scholarship' Terms and Conditions](#). CPA Australia's decision will be final and only the successful applicant(s) will be contacted. A maximum of five scholarship recipients will be selected annually, however, CPA Australia is not obliged to award the scholarship.

### Termination

A scholarship may be terminated, and the recipient will receive no further payments from the date of termination, if any of the following occur:

- a recipient was found to have breached any of the Terms and Conditions, or engaged in any unlawful or other improper conduct calculated to jeopardise the fair and proper conduct of the scholarship;
- a recipient provides false or misleading information in their application or during the scholarship term;
- a recipient ceases their membership with CPA Australia for any reason;
- a recipient fails any CPA Program examination three times (whether it is for the same subject or different subjects);
- a recipient fails to meet the eligibility criteria and conditions of their scholarship;
- a recipient has breached the CPA Australia Constitution and/or By-Laws;
- a recipient is found guilty of a criminal offence.

## Application Procedure

Only applicants who meet the eligibility criteria and submit a complete application package will be considered.

Applicants must submit:

- a completed application form
- evidence of recognition as an Aboriginal and/or Torres Strait Islander i.e., Confirmation of Identity – Verification for Aboriginal and Torres Strait Islander people form, or a statutory declaration stating their identity as an Aboriginal and/or Torres Strait Islander;
- a curriculum vitae (CV)
- evidence of their Australian residency ie, a utility bill or bank statement<sup>^</sup> displaying their residential address;
- a copy of their academic transcript showing subjects passed and grades awarded, the years in which they passed, and the year the degree was awarded (or, if not yet awarded, a copy of their most recent academic transcript).
- a written reference from a member of an Aboriginal or Torres Strait Islander organization; and
- a one-page statement detailing their planned professional career and the reasons for wanting to be a CPA Australia member.

## Terms and Conditions

Applicants, on completing their application form, will be asked to read and accept the CPA Australia 'Aboriginal and Torres Strait Islander Scholarship' [Terms and Conditions](#), outlining the terms and conditions applicable to the scholarship.

## Privacy

Any personal information collected by, or on behalf of, CPA Australia in connection with scholarship applications will be handled in accordance with the CPA Australia 'Aboriginal and Torres Strait Islander Scholarship' Terms and Conditions and the [CPA Australia Privacy Policy](#).
