CPA Australia aims to partner our members to prepare for a globally connected world both now and for tomorrow. In Singapore, we have contributed significantly to the accounting profession over the last 65 years. We are committed to advancing trusted and valued accounting and business professionals who enhance their communities by being the professional learning partner of choice for employers, and supporting our members, the profession and the business community.

CONNECTING THE BIGGEST MINDS

The CPA designation inspires trust, confidence and respect. To profile our members and their respective expertise, CPA Australia collaborated with The Business Times on a thought leadership feature series published in the media organisation's print and digital platforms. The series discussed current and topical business issues that companies face, including digital trends, blockchain, e-payments, and initial coin offerings.

The annual **CPA Congress**, themed Connecting the Biggest Minds, brought together over 380 people from the accounting and finance profession in Singapore. This year's program saw experts, thought leaders and industry disruptors share their insights on the latest business topics such as digital megatrends, socially conscious investing, smart cities and artificial intelligence. The event was graced by Guest of Honour Dr Janil Puthuchear, Senior Minister of State for Transport, Communications and Information.

CONNECTING THE BIGGEST MINDS

At CPA Congress, CPA Australia and PwC Singapore released a new publication titled **State of Digital 2018**. The study of C-suites and finance leaders found that 8-in-10 organisations are either in the midst of a transformation journey or have been through transformation. The report also suggested various digital tools that organisations could employ to support their digitalisation goals.

Promoting the designation worldwide, the **World Congress of Accountants 2018** was co-hosted by CPA Australia in Sydney. Attended by 5,700 delegates, including more than 1,000 CPA Australia members, the event brought together global leaders and finance experts to provide solutions to the challenges facing our profession.



Organisations in Singapore expect significant investments in transformation initiatives over the next 3 years and beyond.

CFOs CONNECT

Over 180 Chief Financial Officers and finance leaders attended the 7th **CFO Connect Symposium** at the Marina Bay Sands Convention Centre. The symposium, sponsored by Accenture and Thomson Reuters, focused on the digital revolution and volatile business environment.

Distinguished speakers analysed technology trends such as the impact of Artificial Intelligence and blockchain on the nature of finance and evolving the role of CFOs as business partners, as well as the current trade and competition landscape facing businesses. CFOs also had opportunity to connect with their peers and build their networks.

LEAD THE FUTURE OF THE ACCOUNTING PROFESSION

CREATING THE FUTURE OF ACCOUNTING

Building a future-ready accounting industry begins with an innovative idea. CPA Australia and the Singapore Accountancy Commission (SAC) joined hands to launch the inaugural **Accounting Innovation Challenge**.

The first hackathon experience for the accounting industry took place on 2 & 3 July 2018. It challenged participants to harness technology to create innovative solutions to real problems in the accounting industry such as in the areas of audit, human resources, governance and compliance, among others.

A total of 29 submissions were received and a final 10 teams were selected to present their solutions to a panel of judges on 22 July 2018. Judges awarded the top prize to a team of Nanyang Technological University students who developed Vulture, a solution that utilises machine learning to digitally analyse business documents to support the mandatory audit process.

The first and second runners-up in the challenge came up with solutions to enhance recruitment of manpower during peak periods as well as improve management of flexi-work arrangements.

CLEAR CACHE. RESTART. PLUG IN.

CPA Australia and KPMG held an in-depth briefing and discussion for the public sector on this year's AGO Report. The annual event examines the findings of the latest Auditor-General's Report. Nearly 200 public sector officers heard panellists share their views on internal audit, finance and procurement.

A new publication by CPA Australia and KPMG was launched at the event. Titled **Clear Cache, Restart, Plug In – Transforming Procurement**, the report analysed developments in procurement and payments from almost three decades of AGO Reports. It maps the changes to the procurement process, as well as anticipates what the future of procurement will look like.

NEXT GEN ACCOUNTANTS

Continuing CPA Australia's efforts to grow the next generation of accountants, CPA Congress in Singapore incorporated a segment curated just for students. The **Students' Symposium** comprised four sessions on digital disruption in the accounting industry.

Over 70 students heard insights from different perspectives – management, a business leader, HR partner and young professionals.

CPA Australia also exclusively partnered SIM Career Office on **Project Protégé**, a mentorship program. Organised by SIM Career Office, this partnership provides

a platform for our CPAs to mentor second and final year students in Accountancy or Accounting & Finance programs from RMIT or University of London. The project allows CPA Australia members to give valuable insights to aspiring accountants by sharing their personal experiences and how they have benefitted from their CPA designation. Over the past year, a total of 160 students signed up to participate in the program.

CPA Australia also worked with RMIT Alumni Singapore to organise a talk on **Digital Disruption: Opportunities or Threat**. About 80 alumnus and current

students from various industries and roles, such as accounting, human resources, IT and logistics, attended the session. They heard from industry experts from EY Singapore, Lion Global Investors and Singapore University of Technology and Design on how digital technologies are impacting their industries.

The event was supported by University of London Alumni Singapore, University of Wollongong Alumni Singapore, and University of Buffalo Alumni Singapore.

Children and adults alike had a blast at the annual Christmas party with games and prizes galore.



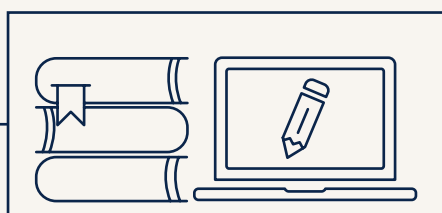
CPA PROGRAM FULL TIME

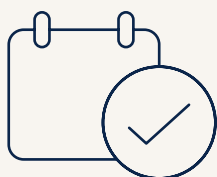

PROVIDE RELEVANT LEARNING AND DEVELOPMENT CONTENT, RESOURCES AND TOOLS

SKILLS FOR THE FUTURE

With technological innovation, there is a critical need for finance and accounting professionals to expand their technical and business competencies. CPA Australia launched the **Finance for the Future** program, a suite of practical workshops designed to meet the lifelong learning needs of professionals operating in a

competitive business environment. The program included topics on accounting standards, finance and operations, disruptive technologies. With the support of e2i and NTUC U Associate, Singaporeans and Permanent Residents also enjoyed subsidies on workshops under this program.



Finance for the Future provided training for accounting and finance professionals to expand their technical and business competencies.

In addition, CPA Australia partnered Singapore Management University (SMU) in the SkillsFuture Festival 2018@SMU, to present a workshop on Big Data and Forensics and launch the **SMU-CPA Australia Finance Game Changer Series**.

This modular professional development program is being rolled out from late 2018 and

through 2019. It covers six 2-day modules for middle- to senior- level finance and accounting professionals and helps them understand and harness the new wave of technologies in the finance and accounting industry. Participants who complete all six modules will receive a Graduate Certificate in Digital Finance conferred by SMU.

ATTRACT AND DEVELOP THE NEXT GENERATION OF CPAS

BE SEEN, GET HIRED

CPA Australia's Profession Session 2018 was held in January to connect students, graduates, and young accounting professionals with employer partners. The annual career fair is one of the largest for the local accounting and finance industry. More than 500 attendees engaged with 10 Employer Partners and 4 Education and Supporting Partners.

Attendees took part in a range of activities designed to help them better prepare to enter the working world. Many had their resumes

checked by professionals and practitioners at the CV Check booth and received personalised advice to ensure they stand out with employers. They also got professionally-taken photos for their resumes and LinkedIn profiles.

CPA Australia members shared their journey and experiences in the accounting industry in an interactive session, allowing attendees to gain a better understanding of the diverse career options in accounting and finance.

Attendees also acquired knowledge about the accounting industry and the CPA qualification through the "Become a CPA" seminars.

More than 40 Student Ambassadors were onsite to support the event, which included roles such as event emcees, ushers and crowd management.

Seven charities joined the event and brought their beneficiaries along to join in the fun and enjoy an evening out. The charities also had the opportunity to showcase their causes.

IMPACT POLICY GLOBALLY AND BE ACTIVE IN COMMUNITY ADVOCACY

RAISING THE BAR

CPA Australia continues to be committed towards raising governance standards among listed companies in Singapore.

In collaboration with the Centre for Governance, Institutions and Organisations (CGIO) at NUS Business School, and Singapore Institute of Directors (SID), the best-governed and transparent Singapore-listed companies were recognised at the annual **Singapore Governance and Transparency Forum**.

They were ranked by the Singapore Governance and Transparency Index (SGTI), a leading benchmark for assessing listed companies on their corporate governance disclosure and practices, as well as the timeliness, accessibility and transparency of their financial results announcements.

The index recorded the highest scores in 2018, reflecting a greater commitment by Singapore-listed companies for better governance. This was timely as the revised Code of Corporate Governance was also

released by the Monetary Authority of Singapore. Speaking at the Forum, Guest of Honour Mr Ong Chong Tee, Deputy Managing Director (Financial Supervision), Monetary Authority of Singapore, stressed the importance of a collective effort to foster a strong corporate governance ecosystem.

RAISING THE BAR

Separately, CPA Australia also extended our partnership with Associate Professor Mak Yuen Teen FCPA (Aust.) of the NUS Business School to publish Volume 7 of the **Corporate Governance Case Studies** series, a collection of teaching case studies.

The case studies are designed to encourage robust discussion and debate on key corporate government issues and developments.

A second volume in Chinese was also produced, in collaboration with CPA Australia's Shanghai office, for use in China, Taiwan and Hong Kong.

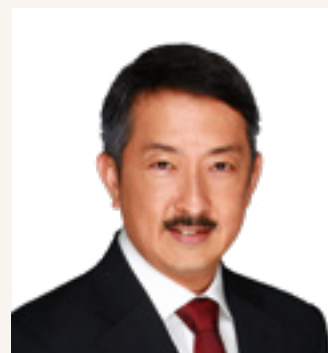
